4. <u>MINUTES OF PRIOR MEETING</u>

David I. Perl recommended certain corrections to the Minutes. After discussion, motion was made by David I. Perl and seconded by Gregg Kronenberger to approve the minutes as corrected pursuant to the comments of David I. Perl. The motion carried unanimously.

Mike Willatt noted that the 120 day deadline will expire on June 4, 2009, following which Terry Irion, on behalf of Evans Weaver, can pursue permission from the TCEQ to annex the Evans Weaver tract into the District.
