Perl to adopt the Resolution Authorizing the Issuance of Senna Hills Municipal Utility District Unlimited Tax and Waterworks and Sewer System Revenue Bonds, Series 2009, Prescribing the Terms and Provisions thereof, Making Provisions for the Payment of the Interest Thereon and Principal Thereof, Authorizing and Awarding the Sale Thereof; Authorizing the Execution of a Paying Agent/Registrar Agreement; and Containing Other Provisions Relating to the Subject as presented. The motion carried unanimously. Mike Willatt represented the Resolution Approving Closing Memorandum. Motion was made by Mike Dansby and seconded by Gregg Kronenberger to adopt the Resolution as presented. The motion carried unanimously. Jerri Strain presented the District's check to the Attorney General in the amount of \$5,200 and the District's check to the TCEQ in the amount of \$500. Motion was made by Mike Dansby and seconded by Gregg Kronenberger to approve issuance of those checks. The motion carried unanimously.

Bruce Aupperle reported on bond application No. 5.
